

ALUMNI HALL OF FAME

This award recognizes living alumni who have achieved national or international distinction by their accomplishments and leadership.

CRITERIA

Consideration will be given for national or international distinction in:

- 1. Career accomplishments, such as:
 - Position within organization
 - Size of employing organization Length of career, including current position
 - Professional appointments
- 2. Leadership within their career organizations, such as:
 - Election to professional associations
 - Leadership role in professional associations
 - Mentoring activities
 - Length and scope of service
- 3. Voluntary leadership efforts in charitable causes, such as:
 - Board/organization membership
 - Board/organization leadership
 - Length of service
 - Scope of impact
- 4. Leadership efforts that have improved the cultural, social, political or economic wellbeing of society, such as:
 - Efforts in fostering human rights
 - Advocate for underrepresented populations
 - Creating awareness for the need for change
 - Pioneering efforts that could result in improving the lives of others
 - Organizing and implementing humanitarian efforts
- 5. Prior recognitions and honors, such as:
 - Career awards/citations
 - Public service awards and volunteer service honors
- 6. Artistic, innovative or technical accomplishments, such as:
 - Patents/copyrights
 - Creative endeavors
 - Significant research efforts



DEADLINE AND PROCESS

Application Deadline: Nomination form must be returned to Alumni Relations prior to September 1.

Nomination form must be complete and thorough. This information is the basis for the evaluation of the candidate.

Note: Nominations may not be submitted for persons currently holding or running for state or national political office.

Review body

Members of the Alumni Association Awards Committee review all completed award nomination packets and then recommend candidates to the full Alumni Association Board of Directors. The full board reviews nomination packets to either approve, disapprove or recommended nominees for future consideration or other awards.

Nominee review and consideration

Completed nomination packets are kept on file and are eligible for review and consideration for an additional two years following initial submission. Nominators are encouraged to update application materials when contacted by the Awards Committee.
