President Scott Green Presiding

- President Green called the meeting to order at 2:30pm (PT).
- President Green read the names of faculty who passed, as from information received by the Provost Office since the previous University Faculty Meeting. Faculty omitted will be recognized at the next University Faculty Meeting.
- President Green requested a moment of silence in honor of the colleagues who passed away.
- Meeting Logistics – Faculty Secretary Sammarruca  
Secretary Sammarruca reviewed the criteria for eligible voting faculty (FSH 1520 II.1.) and the meeting protocol. She encouraged the faculty to raise their hands with questions and to keep the use of the chat function to a minimum.
- Quorum count: Faculty Secretary Sammarruca
  - 98 voting members of the faculty were required for a quorum. 145 eligible voters were counted and thus a quorum was present.
- Approval of minutes – President Green
  - The minutes of the 2024-2025 University Faculty Meeting #2 (May 7, 2025) were approved as distributed.
- Special Orders – Faculty Senate Chair Tim Murphy
  - The Provost read the names of the new members of the university leadership.
  - The Provost read internal changes in the administration.
  - College Deans read the names of new faculty and recognized those who were awarded promotion and/or tenure.
  - Faculty Senate Chair Tim Murphy recognized the faculty senators who completed their terms in 2024-25
  - Consent Agenda  
The faculty approved the spring graduates by unanimous consent.
  - Proposed Changes/Additions to the University Catalog (vote)
    - UCC 163 Change to Admission Requirements

By the current admission standards, students with GPA between 2.30 and 2.59 are admitted into the VGP. Students with a GPA below 2.30 can appeal to the Admissions Committee. The main point of the proposed revisions is to allow students with GPA below 2.60 who have been admitted through VGP to appeal for direct admission. This would remove a double standard with respect to students with a GPA below 2.30, who can appeal to the Admissions Committee for direct admission.

There were no questions or comments.

Vote: 128/136 in favor; 8/136 opposed. Motion carries.

- Proposed Changes/Additions to the Faculty Staff Handbook ([vote](#))

- FSH 4130 Standards Course Numbers

The purpose of these changes is to incorporate the shift to four-digit course numbers that have been implemented over the last couple of years. We add a course number for undergraduate research and reserve some particular course numbers for future use.

There were no questions or comments.

Vote: 141/143 in favor; 2/143 opposed. Motion carries.

- President's Remarks and Announcements:

As you are aware, earlier this month we held our annual State of the University address, in which we recapped another outstanding year and laid out our vision for the next five years under our new strategic plan. The full State of the University Address is available on our website under Presidential Communications. As a reminder, grant proposals for funding of strategic plan projects are due October 1.

Our numbers will not be official until census day next month, but we're expecting a record number of students on campus this fall. It is unlikely we'll meet our record number of freshman from last year due to our international student numbers being down. But this would be our ninth straight semester of enrollment growth, which is a big win as we hit the enrollment cliff this year. Students continue to seek out the U of I because they get an outstanding, yet affordable education.

Our enrollment success fuels our financial health. Our budget management has turned into an overwhelming strength thanks to the hard work of our employees and the thoughtful stewardship of our finances. Through the hybrid budget model and our P3 initiatives, we have added about \$15 million to invest in our strategic priorities over the past three years.

Last month, the governor announced a 3% budget reversion for fiscal year 2026. For the University of Idaho, this means a \$5 million reduction in state appropriations. This is a state's funding issue, and recent reports on revenue projections indicate that these cuts will likely be permanent. It is in no way a reflection on the great work happening at the University of Idaho. Full details about the budget reduction and our plans to move forward are available in the memo sent out August 19.

Our research enterprise continues to grow and thrive thanks to the hard work of our employees. We once again set a record for research expenditures, topping \$140 million in 2024. As we deliver on our land grant mission of access for students and research for our state, we provide \$2.5 billion dollars in economic impact in Idaho each year.

We are national leaders in a wide variety of research, including water, soil health, agriculture, forestry, fire, and artificial intelligence. Despite significant challenges at the federal level, we continue to win grants. In recent months we received grants for our Center of Biomedical Research Excellence in Nutrition and Women's Health, the Institute for Modeling Collaboration and Innovation, and our INBRE program, which celebrates 25 years of research excellence this year.

On the topic of our website, our team has been working hard to address issues since the launch of our new site last month. If you identify issues, please reach out to Seth Vieux at [sethv@uidaho.edu](mailto:sethv@uidaho.edu). We continue to work on the search functions in both .edu and intranet. They have improved and will continue to be refined. Faculty, emeritus faculty, and post-doc profiles are being added to the .edu site and are a UCM priority.

Our website gets over a million hits a month and is a major driver of enrollment. The new site is strongly outperforming the old site in virtually every measure we're tracking. Our quality assurance score, which measures the customer's journey on the site, jumped nearly 14 points to 91 out of 100. We're also seeing much higher scores in SEO, accessibility, and digital certainty.

We appreciate the great work of our faculty, and we look forward to building on our success over the next five years.

President Green opened the floor to question.

A faculty asked whether there is a plan in the works to provide a university vaccine clinic this fall.

Provost Lawrence responded that there has been discussion about that. It is more complicated than the COVID vaccine availability. The team that has managed those in the past is looking into the question, and we may expect some messaging about that soon. The provost will follow up as well.

President Scott Green Presiding

- President Green called the meeting to order at 2:32pm (PT).
- President Green read the names of faculty who passed, as from information received by the Provost Office since the previous University Faculty Meeting. (The names can be found in Attach. #1 of the binder for this meeting.) Faculty omitted will be recognized at the next University Faculty Meeting.
- President Green requested a moment of silence in honor of the colleagues who passed away.
- Meeting Logistics – Faculty Secretary Sammarruca  
Secretary Sammarruca reviewed the criteria for eligible voting faculty (FSH 1520 II.1.) and the meeting protocol.
- Quorum count: Faculty Secretary Sammarruca
  - 98 voting members of the faculty were required for a quorum. 149 eligible voters were counted, and thus a quorum was present.
- Approval of minutes – President Green
  - The minutes of the 2024-2025 University Faculty Meeting #1 (September 4, 2024) were approved as distributed.
- Special Orders – Faculty Senate Chair Kristin Haltinner  
Chair Haltinner acknowledged the many hardships our academic community has faced this year, including the loss of essential grant funding, the closing of the equity centers, members of our community facing fear of deportation, and threats to academic freedom. Faculty Senate will continue to work for faculty and staff and bring all voices to the table.
  - Consent Agenda  
The items below were approved by consent:
    - University Committee Appointments for AY 2025-26
    - AY 2025-26 Sabbatical Approvals
  - Proposed changes/Additions to Faculty-Staff Handbook  
The two items below are to be taken as a bundle.
    - FSH 1520 Constitution of the University Faculty (V-2 Clause B and V-3)  
Revised to clarify the past chair terms of office and to highlight the expected continued service of the vice chair (except in special circumstances). These changes are based on proposed revision to FSH 1580 Bylaws of Faculty Senate.
    - FSH 1580 Bylaws of Faculty Senate (II-3, III-2, IV-1,2)

The recommendations here are intended to improve the strength and continuity of faculty senate/faculty senate leadership. They include two changes: 1) to make it clear that it is expected that a vice chair will continue as chair except in special circumstances (resignation or a vote of no confidence) and 2) create the position of past chair. This would be an advisory role that would support the chair and vice chair and serve on the executive council. There is also a change to Article IV, Section 2. At present the policy indicates that the chair/vice chair will be elected three days after the nominating meeting. In practice, we do this 1 week later. The policy was edited to mirror the practice.

There were no questions or comments.

Vote: 131 yes; 5 no. Motion passes.

- **FSH 1520 Constitution of the University Faculty (V-7 Clause A and V-8)**  
Revisions (mostly in Article V Section 7 Clause A and Section 8) are needed to provide missing information in the selection process of alternate senators in case of a senator's absence or recall.

There were no questions or comments.

Vote: 138 yes; 2 no. Motion passes.

- **FSH 3780 Dependent Educational Tuition and fee Reduction**  
In 2024 Faculty Senate created an *ad hoc* committee to examine the possibility of expanding the dependent tuition benefit to include more than one child/dependent at a time. This committee worked with the DFA and the President's Office to develop the changes herein. These changes include the addition of a second eligible dependent at a rate of 25% off tuition. (The first child will continue to receive the 50% reduction).

There was no discussion.

Vote: 145 yes; 2 no. Motion passes.

- **FSH 1580 (V-11) Bylaws of Faculty Senate**

This is to allow the Senate to use electronic ballots, which is the current practice.

There was no discussion.

Vote: 145 yes; 1 no. Motion passes.

- **FSH 1640.82 Faculty Compensation Committee**

This would create a faculty compensation committee to make recommendations to the provost regarding raises and other aspects of compensation. The creation of this committee was reviewed and developed in partnership with the existing Staff Compensation Committee, the Faculty Affairs Committee, the *ad hoc* Committee on Faculty Salaries and the Committee on Committees.

There was no discussion.

Vote: 141 yes; 4 no. Motion passes.

- **FSH 3130 Disruption of University Operations**

New policy FSH 3130 Disruptions of University Operations has been developed jointly by the Faculty Affairs Committee, Staff Council, and the Faculty Staff Policy Group. It gives all employees the opportunity to make recommendations to their supervisors regarding temporary adjustments to their responsibilities during a disruption to university operations such as a natural disaster or public health emergency. It also gives employees the right to submit a description of the disruption's impact on their work, to be used in the evaluative process.

There was no discussion.

Vote: 142 yes; 5 no. Motion passes.

- **FSH 4000 Academic Freedom and Responsibilities**

FSH 4000 as it currently stands refers directly to the board policy. We propose taking the language directly from the state board and placing it in FSH. Doing so will ensure that faculty are aware of and engaged with any future changes to the policy made by the board rather than automatically having our policy change (because of their change).

Discussion

A faculty inquired about the potential for the legislature to circumvent the SBOE in these matters, and whether that was considered. The provost joined the discussion and said that state law overrides SBOE policy and SBOE policy overrides U of I policy. So, for example, if the legislature mandated something that is in conflict with an SBOE policy, then SBOE would need to remove the conflict. We're getting many questions about SB 1198, which does reference academic freedom, and we're working with the board to finalize guidance on that.

Vote: 137 yes; 8 no. Motion passes.

▪ **FSH 4310 Academic Advising and Counseling**

The policy is revised to reflect current and recommended practices. The University Advising Committee has been working on this for three years and drastically rewrote it. The key highlights of the updated policy include the addition of a description of faculty mentoring and the preservation of college autonomy to make their own decisions regarding the role of advising.

Discussion

A faculty member inquired about the difference between a professional advisor and an academic advisor. Based on section **D-2 Academic Advisors**, which reads "A faculty member or professional advisor may serve as an academic advisor," the provost's understanding is that an advisor is a faculty member who is advising, or a staff member who is advising.

Another faculty shared their understanding from conversations at UCC. A professional advisor is preferred for the first and second year, after which the advisor's role would typically move to a faculty member, because of the nuance of the academic choices that need to be made. The Dean of COGS Jerry McMurtry noted that, at the graduate level, the major professors are responsible for providing guidance, mentoring and advising. Thus, the above relates to undergraduate students only. Also, the major professor is required to be a member of the graduate faculty, which excludes anybody on staff from serving in that role.

Proposed amendment (McMurtry, Awwad-Rafferty): Modify section A to read "*This policy regulates academic advising and mentoring for undergraduate students at the University of Idaho.*"

Discussion on the amendment

In favor: It provides clarity, and that's good in policy.

Concern: With this amendment, there would be nothing to address advising in a college with only graduate students.

In favor: The graduate advising aspects are covered in the Catalog.

Against: In the revised policy, each college is given the autonomy to establish its own advising model. This should cover the College of Graduate Studies as well, making the amendment unnecessary.

Reply by Dean McMurtry to the above comment: We do have catalog language that specifies role and responsibility of the major professor. But each college operates somewhat differently under the overarching guidance of the graduate school.

Vote on the amendment: 112 yes; 27 no.

Vote on the original motion as amended: 134 yes; 8 no. Motion passes.

The three items that follow, FSH 4120, FSH 1640.94 and FSH 1640.93, will be addressed as a package.

- **FSH 4120 Catalog Change Procedures**

In AY 2023-24, FSH 4120 was amended to expand the authority for submitting curriculum change proposals to UCC (previously limited to department units and colleges) to include the authority for interdisciplinary faculty committees to submit proposals to UCC for intercollege interdisciplinary programs. The change last year was catalyzed by the formation of a university wide committee to develop and maintain curriculum for the Academic Certificate in Sustainability. The demand for interdisciplinary programs is such that concerns arose this year around the creation of Faculty Senate-appointed committees for each individual intercollege program, both existing and newly proposed. The change to FSH 4120 proposed here is to formalize just one university-wide Faculty Senate-appointed Intercollege Curriculum Committee (ICC) to serve in a role analogous to colleges for curriculum change process (only) for intercollege programs. Faculty working groups for individual intercollege programs will continue to serve in a role analogous to departments with respect to submitting curriculum changes for intercollege programs to the newly formed ICC.

- **FSH 1640.94 University Committee on Intercollege Curriculum**

This change will create the Intercollege Curriculum Committee as proposed by an *ad hoc* committee based upon a charge from Faculty Senate to review the issue.

- **FSH 1640.93 University Committee for Academic Certificates in Sustainability (Deletion)**

Deletion of this policy is proposed because, if the proposed ICC Committee (FSH 1640.94) is approved, it will replace the need for 1640.93, which would become a working group independent from Faculty Senate oversight.

Discussion

Motion to amend (James, Smith): Add to the end of FSH 4120 E-1.a and 4120 E-2.a the sentence "*Intercollege programs established before Spring 2025 and administratively housed in a single college or with specialized accreditation requirements can choose to take curricular changes through their home college instead of the ICC.*"

Discussion on the amendment

In favor: This is important with respect to accreditation requirements.

There was no additional discussion.

Vote on the amendment: 135 yes; 4 no.

Back to the discussion of the entire bundle, Dean McMurtry noted that Graduate Council sits before UCC and is made up of representatives from every college as well as graduate students from GPSA. It also has representatives of "university-wide programs," which is the terminology used for the graduate level interdisciplinary programs. So, these changes to FSH 4120 should not apply to graduate programs, which don't have a curriculum that exists in the catalog.

Reply to the above concern: The proposal is basically to replace the college level committees by the Intercollege Curriculum Committee for programs that require more than one college to design and maintain. So, if a graduate program fell under that rubric, it would go through the Intercollege Curriculum Committee, then Graduate Council, then the University Curriculum Committee.

Motion to amend (James, Hohenlohe): Add the sentence to FSH 4120 E-1.a and 4120 E-2.a "*Any graduate level program that progresses through the ICC must also be vetted by the Graduate Council before review by the UCC.*" The reason for this amendment, rather than specify that the ICC is for undergraduate curriculums only, is because there are plans in the

works on graduate level certificates that are intercollege and would like to progress through this ICC.

Discussion on the amendment:

After some more discussion and a proposed amendment to the amendment (Carney, Smith) to clarify that Graduate Council should vet the program before review by UCC, it was determined that the best course of action was for James and Carney to withdraw their motions and start with a new motion (James, Kerr) to add the sentence to FSH 4120 E-1.a and 4120 E-2.a "*Any graduate level program that progresses through the ICC must then be vetted by the Graduate Council before review by the UCC.*"

Vote on the above amendment: 117 yes; 7 no.

Back to original policy bundles, Dean McMurtry reiterated that he does not see the need for the ICC at the graduate level. A faculty who had been especially active with the ICC cited the case of Water Resources as a helpful example. Because they are housed in the College of Agriculture, a curriculum proposal is routed through the College of Agriculture Curriculum Committee, where departments are represented that have no real purview related to the proposed program. ICC provides a second check on whether there are any issues within other colleges.

Against the motion: While the policy as written would work well for certificates, the addition of a secondary tier of curricular processes for degrees is concerning, especially across-college degrees. We should be streamlining curricular processes.

In favor: Without ICC, there is no creating any new interdisciplinary programs at the graduate or the undergraduate level, unless it goes through either a single college or every college on campus. We don't have the capacity to go through every college. Thus, without an ICC, there is no mechanism other than going through a single college.

Against: There are concerns about the deadlines. There has been incredible work from Sande Schlueter and Gwen's team to create a crosswalk. Where would this deadline hit? With the October 1 deadline to get programs out of the college, another added layer is worrisome.

In favor: Maybe this isn't something that is applicable to our degrees. But, if someone wants to move into more interdisciplinary work in terms of teaching and programming, there are very few easy ways to do it, which is frustrating.

There was a question about resources: Who's going to teach the courses in the program? How are you going to fund this? Is the ICC going to make those decisions?

Reply to the above question: It's important to make clear that we are not talking about budgets. UCC receives information about programs and how much they cost. But we are really there to vet curriculum, right degree maps etc. The same would apply to the ICC. We have chatted about the necessity, for example, to have faculty working groups include letters of support from deans of the colleges that are involved in the programs when proposals come through the ICC, to make sure that deans, who are making decisions about allocation of resources, are aware and supportive of those programs. So, this is something that the *ad hoc* committee has been very aware of and something that we would like to enact in the in the proposal process, should this committee be approved.

In favor: The former director of Environmental Science, which is one of the university-wide programs, spoke in strong favor of this. I think that the ability to have ownership of these important programs across the university, as well as increasing participation in them, adds a lot of collaborative ideas and interactions through the curriculum process. I think that's something that we really need to infuse into these programs.

There was no more discussion.

Vote: 98 yes; 16 no. Motion passes.

- FSH 1640 Committee Directory

These changes will update multiple sections of FSH 1640 that have become out-of-date with position titles and office names across the University over the last several years. Several substantive changes are also included to better align the committee memberships with the current university structure; remove designated senator seats from committees where they are not necessary; resolve ambiguous language in the current policy; reduce the usage of designated position titles where a representative from the appropriate unit will suffice.

There was no discussion.

Vote: 108 yes; 3 no. Motion passes.

- FSH 1620 (D-17) University Level Committees

This revision is to ensure that IRB, IBC, IACUC committee meetings are not open to the public to protect confidentiality and to comply with Idaho Open Meetings Law. Idaho Law does not require the foregoing committee meetings to be open to the public.

Discussion

There was concern that this change would remove transparency. Arguments in favor of the motion: The purpose of this policy is to allow those committees to have the ability to communicate freely about potential issues and concerns in those meetings. This policy does not change the fact that those meetings and proceedings are still subject to public records law. If there's any questions or concerns about research matters that are under the purview of these committees, you can work with the office of general counsel to request the relevant records. If a member of the IRB is present at this meeting, it would be helpful to have their input on this.

Member of the IRB: The IRB is subject to heavy federal regulations which they must comply with. IRB deals with intellectual property proposals. We cannot share the details of those studies in a public forum until the study is run and published. There could also be a personnel issue, which must be kept confidential. There are good reasons why those meetings are not public.

Against: Not comfortable with reduced transparency.

In favor (Kay Dee Holmes, Office of Research Assurances): There have been abuses in the past with human subject research, which is why the IRB system was created. The University's policy in making these meetings close to the public is consistent with how other universities across the country function. Closing these meetings to the public allows the committees to really delve into the issues and discuss things clearly without being worried about their words being used against them. And so, these meetings, being closed, will allow for free discussion of ideas, issues, and concerns, while being able to balance that with a FOIA request for public records.

Against: These reasons do not raise the bar quite enough to remove transparency.

In favor: When these meetings are open to the public, they may also require confidentiality agreements signed by anyone who is witnessing or attending those meetings. Motion (Boysen-Taylor, Awwad-Rafferty): Send it back to the Faculty & Staff Policy Group for further review.

Discussion on the motion

In favor: If there are other ways to approach the issues that have been raised, we should consider them before moving forward.

Clarification from Holmes: The chairs of the IR committees have discretion to allow people to attend. So, the meetings are not automatically closed. Someone who wishes to come needs to get permission from the chair.

Against: It's best to make a decision now.

Vote: 55 yes; 53 no. Motion passes.

- FSH 4250 Continuing Education and Correspondence Study

Current policy is out of date. The revision reflects current processes and provides clarification regarding continuing education and correspondence study at the U of I.

Vote: 105 yes; 2 no. Motion passes.

- FSH 4800 Language Skills (Deletion)

Following comprehensive review, FSPG proposes to delete FSH 4800 Language Skills because it does not meet the FSH 1460 E-2 criteria for inclusion in the policy library.

Vote: 107 yes; 4 no. Motion passes.

- President's Remarks and Announcements:

It's my understanding that Senate leadership for the next term has been determined, and congratulations are in order to Tim Murphy, who will be the chair, and Kristen Haltinner, who's agreed to continue serving in the vice chair role. So, they've just switched chairs, but that gives great continuity. Congratulations to both of you.

I apologize that these remarks and announcements are a little longer than usual. A lot has been going on, and we received vast feedback about what you wanted to hear us talk about.

We continue to build momentum in many areas across the university.

We posted our 8th straight semester of enrollment growth. Our overall enrollment, not including dual credit, is up 4.2% over last year. As I've reported before, in the Fall we welcomed our largest freshman class ever, with more than 2,000 new students and a 4.4% increase overall. We've also done a great job bringing in graduate students. Our total graduate student enrollment is up 2.4% over last spring and doctoral student enrollment is up 8.4% over last spring. So, at a time when universities and colleges across the country are experiencing declining enrollments and closing at a rate of one per week, our growth truly is an outlier. Looking at next Fall, our undergraduate applications and acceptances are basically flat compared to last year's record class. We've had great turnouts at our first two Idaho Bound orientation events and registration for upcoming events is on par with previous years. If we're able to match last year's record results, we will have the largest total enrollment in our history.

As you know, we proudly announced earlier this spring that we are a Carnegie-rated R1 university. We joined the top 4% of universities nationwide, and this classification recognizes the depth and breadth of our research and the great work of our talented faculty. Our research expenditures were more than 140 million last year, and that's more than all other Idaho public institutions combined. We are national leaders in water, soil, fire, energy, forestry, and a range of agricultural research. These accomplishments in total are truly remarkable, particularly given all we've been through these past six years. Our results are in stark contrast with what's happening at other institutions around the nation and are something of which we all can be proud.

Turning to the future, yesterday at our Town Hall meeting we presented the draft of our new strategic plan, which is now posted on our website for your comments. Feedback will be accepted through Sunday, May 18. <https://www.uidaho.edu/president/university-working-groups/strategic-plan>

The five pillars that have emerged at this point are: empower student success, ensure 100% of students participate in experiential learning, transform the educational model, serve Idaho through research, innovation and partnership, and enhance operational excellence. We've learned a lot about ourselves throughout this whole process. Our working group, with guidance from Huron Consulting, crafted a plan that I believe represents our values and puts our university first. Every college, unit, and member of the Vandal family can plug into our new plan and guide their decision making going forward. We've identified initiatives within each pillar to drive progress and inform where we invest. Unlike our previous strategic plan, which was admittedly unwieldy, and tried to make everybody happy, our new plan aims to benefit the institution as a whole. The plan does not identify operational silos, mention each research area, college or unit, or differentiate between faculty and staff. It does, however, serve the entire university and everyone's contribution towards our goals is needed, valued, and remains vital to our common success. If executed, this plan strengthens our overall ecosystem, creating a foundation that builds on our strengths. It makes us more competitive. I am incredibly excited about this path we are about to take. There will continue to be disruption and technological change impacting higher education. We know that AI will remake how we support our employees and how each of us goes about doing our work. It will impact on our programming and how we prepare our students to compete in a new environment. Some change will be unwelcome. Others will make our jobs easier, enabling us to focus on the more important aspects of our work. Our strategic plan, together with our mission, vision, and values will provide the north star so that we can nimbly navigate and adjust to this ever-changing environment without losing our bearings. The comment period is now open till May 18<sup>th</sup>, extended from May 16<sup>th</sup>. We look forward to your comments.

Turning to the legislative session, we are assessing the effects of Senate Bill 1198, which include banning DEI programs and offices, prohibiting DEI training, curricular restrictions, and restricting DEI use in hiring and admissions. The legislature will require a review of our DEI programs by the legislative services audit team, including a two-year look back. This audit process will require us to work quickly in lockstep with our sister institutions and the State Board of Education to assess and address the new law, and I can assure you that it is well underway. We've had a meeting today, and I'm very pleased with how much progress has been made. As a result of both the SBOE resolution in December and SB 1198, we have closed the DEI units on campus. The spaces that were previously assigned to DEI have been reassigned for different functions. The Women's Center and the Office of Multicultural Affairs and Diversity Center are now closed, and our employees have been reassigned primarily to Vandals First, a unit which focuses on assisting all first-generation students at the University of Idaho. The Violence Prevention and Education Office is open and student clubs and organizations, such as Unity, the Black Student Union, and the Gay Straight alliance, are still allowed. We want to make sure that students can gather and form their own groups, as it is their first amendment right to do so. We will continue to host cultural education events on campus, such as Taste of Nepal, Bangladesh Night, and Cruise the World. These cultural events are open to anyone, and we encourage everyone to attend. They're a lot of fun and help showcase the rich heritage and cultures of many of our students. While we have had challenges and are currently reviewing the bill to determine what additional actions we may need to take, we continue to lead with the students as our focus, even though it may look different from how we've done it in the past. We will support all our students, so they can go on to success, both here at the university and in their chosen careers.

At the federal level, the president's proposed budget would dramatically cut several research sponsored programs that will affect not just the University of Idaho, but the entire research development ecosystem in the US. It seems all higher education is being painted with the same brush. This is really an unprecedented situation, and we continue to advocate for our university with our delegation emphasizing the vital role we play in the state and the nation. We're taking steps as a university to mitigate the impacts where we can. The Office of Research and Economic Development and the Office of Special Programs are assisting faculty on the ground as we face potential grant reductions of 1.7 million from NIH and 16.6 million from NSF. We're working with the Governor's office, the State Board and our delegations regarding termination of federal grants, and how they hinder our ability to deliver the results that improve educational economic workforce development, natural resource management and agricultural outcomes for Idaho. We're also working with faculty on appeals and with PIs to wind down programs and ensure that we can collect reimbursements for expenditures. OSP is following up with direct invoices to agencies for federal grants that have been paused to ensure we have our expenses on record. The U of I is interacting with national organizations to convey to Congress the impact of these cuts. Vice President Nomura is also part of the Vision for American Science & Technology (VAST), a task force that supports America's global leadership in Science & Technology. We're fortunate to have such a strong leader in Chris Nomura and his team to help us navigate these changes and protect the University to the extent possible. The next step is for Congress to hear these budget recommendations and to hear from the courts regarding the legality of some of the contract terminations. In the meantime, we should stay focused on what we can control and mitigate the impact of these actions to the extent possible.

Turning to another topic, we're very pleased to announce that Leslie Edgar will be joining us as the new Jr. Simplot endowed Dean of the College of Agriculture and Life Sciences. She comes to us from Washington State University, where she served as Associate Dean of Research for their College of Agricultural, Human and Natural Resource Sciences, and the Director of the Agricultural Research center. Leslie grew up in Cuna, Idaho, and has spent nearly her entire career at Land Grant Universities. She has big shoes to fill, as Dean Parrella has led that college with distinction and the most significant faculty facility upgrades in our history. She's well prepared for the job, and we're excited to have her get started to build on the great things that are happening in CALS.

On another note, we hope to see you at commencement this weekend in Moscow, one of our favorite times of the year, or later this month in Boise or Idaho Falls. Our commencement speaker in Moscow is Hamdi Ulukaya, founder and CEO of Chobani, and we're excited to celebrate more than 2,200 graduates this spring.

It's undeniably a challenging time for higher education. We've done much to strengthen our university over the past few years. and that will help us weather the storm. And it is a storm that we're currently experiencing. But storms eventually pass. This spring reminds me of the stress that our campus felt during the pandemic, and we had to close our doors. Then, as is the case now, how we respond will determine whether we come out of this latest challenge frightened, hobbled, and weak, or we shelter together, take care of each other and emerge stronger and better fit to adjust and compete in the new environment. Now, as we did then, let's look out for one another. Stay clear eyed, prepare for the future, adjust where needed. Keep calm, and as always, *vandal on!*

I'm happy to answer any questions that you may have.

Discussion:

President Green and Provost Lawrence were asked to which extent faculty should be making changes in response to what is happening in the state with higher education. They created a working group for this purpose and are soliciting feedback from our regents and the state board. People should not be changing their courses or curriculums right now, because they might be making changes that aren't needed. Due to the way the bill (soon to be law) is written, it is very difficult to comprehend the impact on a course or a program, and that is what we're working through right now. First, we need to identify where our concerns are, and then we will look at those concerns and determine the best solutions, such as a change in the curriculum or in the course itself. There are many different things we could consider. A major factor is whether students have other options, and if they do, there is no problem with a course. We are also trying to make sure that all eight institutions are on the same page, to avoid confusion. We're also waiting for guidance from the state board office on a few of these concerns, and we hope to hear within the next week. So, faculty who are teaching summer classes may get some details tomorrow or Friday. They will not ask you to change anything except for including some disclaimer language for the students, probably for the fall. Our approach is to minimize impact while staying compliant.

In response to a comment in the chat about whether FSH is being reviewed, President Green said that a very broad-based review is being done across all of our public facing communications, websites, and postings. Then, everything goes to OGC, who will weigh in on what's out there that can be problematic. We're trying to make sure we are not infringing on any parts of the law, while avoiding making changes we don't have to make. We're trying to take a very conservative approach.

There was a brief exchange about possible "bridge funds" to help PIs impacted by grant cancellation. There are a few private entities that have developed a rapid response bridge grant opportunity for scholars impacted by NSF Grants cancellation.

Comment from the chat space: For those of us who have a tight curriculum connected to accreditation, this(options) might be problematic for the classes because we need to maintain rigor and meet professional health, life safety and welfare requirements.

In response, Provost Lawrence said this is part of the policy where we're waiting for clarification, that is, a process where the State Board can approve exceptions. It may be at the program level, but that's being debated. We're waiting for some details that will determine whether an exception process or some other mechanism is the best way to deal with it.

Concerns were raised about TRIO being the next federal program to lose funding. President Green said that TRIO is a likely target.

President Green encouraged everyone to attend the Commencement. It'll be good to see everybody and celebrate what we really do here, which is illuminate and elevate our students and get them ready to go out and compete in the world. We are a great Vandal family, and we will get through this, too, as we always do. Thanks everybody and go Vandals!

In order to eliminate a double standard in admissions requirements for students with high school GPAs below 2.6, we propose the following modification to admission standards:

#### Current admissions standards:

New first-year students entering in Summer 2025 or Fall 2025 with a cumulative unweighted GPA of 3.00 or higher are eligible for admission regardless of test scores. Applicants who are Idaho residents achieving scores of 3 or higher on both the ISAT Math and Literacy tests are eligible for admission regardless of GPA. New first-year applicants with a cumulative GPA between 2.60-2.99 must submit ACT or SAT test scores and meet the minimums listed below. Those who have cumulative GPAs of 2.30-2.59 will be admitted through the Vandal Gateway Program regardless of test scores. Students with GPAs below 2.30 may appeal through the Admissions Committee.

#### Revised admissions standards:

New first-year students entering in Summer 2026 or Fall 2026 with a cumulative unweighted GPA of 3.00 or higher are eligible for admission regardless of test scores. Applicants who are Idaho residents achieving scores of 3 or higher on both the ISAT Math and Literacy tests are eligible for admission regardless of GPA. New first-year applicants with a cumulative GPA between 2.60-2.99 must submit ACT or SAT test scores and meet the minimums listed below or be admitted through the Vandal Gateway Program. Those who have cumulative GPAs of 2.30-2.59 will be admitted through the Vandal Gateway Program regardless of test scores. Students with GPAs below 2.30 may appeal through the Admissions Committee to be admitted directly to the university or to the Vandal Gateway Program. Students who have been admitted to the Vandal Gateway Program may appeal to the Admissions Committee to be directly admitted to the university.

#### STANDARD COURSE NUMBERS

**LAST REVISION:** July 2011

**A. STANDARD COURSE NUMBERS.** University-wide standard numbers have been established for certain categories of courses. These courses need not be listed in a subject-field section in the catalog. They may be offered and listed in the Class Schedule whenever they are needed. Catalog course numbers are assigned by the Office of the Registrar at the time of approval by the University Curriculum Committee.

**B. AUTHORIZED COMBINATIONS OF STANDARD COURSE NUMBERS AND TITLES.** The following course numbers and titles are authorized: 2000, 4000, 5010, 6010 Seminar; 2030, 4030, 5030, 6030 Workshop; 2040, 4040, 5040, 6040 Special Topics; 4050, 5050, 6050 Professional Development; 2980, 3980, 4980, 5980, 6980 Internship; 2990, 4990, 5020, 6020 Directed Study; Optional 4000s number Practicum in Tutoring; 2999, 4999 Undergraduate Research; 5000 Master's Research and Thesis; 5970 Graduate Practicum; 5990 Non-thesis Master's Research; 6000 Doctoral Research and Dissertation. (Courses in this group that are appropriate to the College of Law are assigned analogous numbers in the 8000s and 9000s.)

#### C. CONDITIONS.

**C-1. Authorized Fields.** With the exception of Practicum in Tutoring, the undergraduate-level standard courses may be offered in any subject field, excluding those approved for graduate degrees only. Practicum in Tutoring and Undergraduate Research courses may be offered in subject fields in which a bachelor's degree has been approved. Courses 5010, 5020, 5030, 5040, 5050, may be offered in subject fields in which graduate-level courses or degree have been approved. Courses 5970, 5980, 5990 may be offered in subject fields in which a graduate degree has been approved. Course 5000 must be offered in, and only in, those subject fields in which a thesis master's degree has been approved. Course 6000 must be offered in, and only in, those subject fields in which the Ph.D. or Ed.D. degree doctorate-level programs are offered, has been approved. Courses 6010, 6020, 6030, 6040, 6050, 6980 must be offered in, and only in, those subject fields in which doctoral-level programs are offered.

**C-2. Expanded Titles and Descriptions.** All of the foregoing titles, except for 5000, 6000, and Practicum in Tutoring, may be expanded (in the nature of subtitles) to indicate the subject more specifically. This possibility is indicated by the symbol "(s)" between the number and the title in the catalog entry. If more than one such specific topic is to be offered, they will be listed in the Time Schedule as separate sections. Also, special conditions or restrictions may be added to the course description. Illustrative catalog entry: MusH 4000 (s) Seminar (cr arr); Illustrative Time Schedule entries: MusH 4000 Lec 01 Seminar (cr arr); MusH 4000 Lec 02 Seminar in Ethnomusicology (3 cr); MusH 4000 Lec 03 Seminar in Medieval Music (1-3 cr).

**C-3. Credits.** All of these courses, except Practicum in Tutoring, may be offered on a variable-credit basis (cr arr). Practicum in Tutoring is to be offered for one credit and may be repeated once (1 cr, max 2).

**Directed Study:** -A method of delivering specially designed content to a student outside of the normal classroom environment. A student cannot repeat the same directed study. Directed study courses cannot duplicate an existing course.

**Internship:** Supervised practical experience related to a student's major.

**Practicum:** Course of study that involves the supervised application of previously studied theory.

**Practicum in Tutoring:** Tutorial services performed by advanced students under faculty supervision.

**Professional Development:** A professional activity designed to provide information or skills, which have practical value. Usually developed to meet the needs of a particular group of practitioners.

**Graduate Research:** Supervised collection of information about a particular subject.

**Seminar:** A course offered to a group of advanced students studying under a professor with each doing in-depth study and discussion of the course material with the professor and other students.

**Special Topic:** Extended discussion on a topic or subject area not covered in an existing course offering. Topic cannot be offered more than three times under this course number. After the second offering appropriate curricular approval paperwork must be filed.

**Workshop:** A usually brief, intensive course for a relatively small group of students that focuses on techniques and skills in a particular field.

**Undergraduate Research:** A mentored investigation or creative inquiry conducted by undergraduates that seek to make a scholarly or artistic contribution to knowledge.

**C-4. Prerequisites.** Prerequisites are not usually listed for courses 5000. Courses in the 6000-series are intended for doctoral students only and will carry a system-enforced prerequisite of enrollment in a doctoral program (Ph.D., Ed.D.).

**C-5. Grading.** Seminars, workshops, directed studies, Practicum in Tutoring, and internships may be graded on the P/F basis or normal mode.

**C-6. Limitations.** A separate special-topics course should not be offered under the number 2040, 4040, 5040, or 6040 more than three times; after the third offering, it should be assigned its own number, title, and description so that with few exceptions the official descriptions of courses students take will be in the catalog. Use 5990 for research not directly related to a thesis or dissertation. A maximum of 10 credits in course 5000 may be applied toward the minimum of 30 credits required for a thesis master's degree; nevertheless, the number of credits a student may earn in course 5000 is not limited to the number required by the student's department. Credit in course 5000 cannot be counted toward the minimum of 30 credits required for a nonthesis master's degree. Credit earned in 4050, 5050 and 6050 will not be accepted toward graduate degree programs. Courses numbered 6000-6999 may never be conducted jointly and can be cross listed only with 6000-level courses in a second department. Standard course numbers may not be cross- or joint-listed with catalog courses

**C-7. Limitations on Directed Study.** Directed study is intended as a method of delivering specially designed content to the student outside of the normal classroom environment. General classroom space is not available for this purpose and enrollment in any directed study course should not exceed five. Students cannot repeat the same directed study. Directed study courses cannot duplicate an existing course.

**C-8. Reserved Standard Course Numbers.** Course numbers 2991, 2992, 2993, 2994, 2995, 2996, 2997, 2998, 4991, 4992, 4993, 4994, 4995, 4996, 4997, 4998, 5991, 5992, 5993, 5994, 5995, 5996, 5997, 5998, 6991, 6992, 6993, 6994, 6995, 6996, 6997, and 6998 are reserved for future standard course numbers and may not be used for regular catalog courses.
