### **Executive Orders**

Executive orders replaced the negotiated treaty after 1871. In 1919 Congress prohibited the creation of reservations by executive order. Since 1936, executive orders have been printed in the *Federal Register* and the *Code of Federal Regulations: Title 3-The President*. Though there is no official collection of executive orders prior to 1936, there are several unofficial collections providing early executive orders relevant to Indian affairs.
