# WHAT IS DUAL CREDIT?

The University of Idaho Dual Credit Program allows high school students to earn college credit prior to graduating from high school. Credits earned through the U of I can be applied towards high school and college graduation and can be transferred to other colleges or universities.



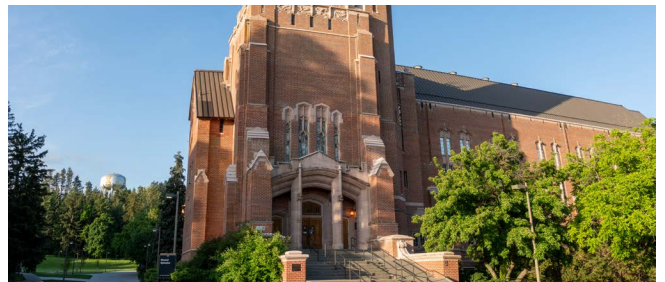
# WHAT ARE THE BENEFITS?

- **Save money** – State of Idaho residents enrolled in a public or private high school or homeschool are eligible for discounted tuition of \$75/credit.
- **Flexible options** – Take college courses online, on a U of I campus, or at your high school.
- **Experience college** – Gain confidence and explore potential pathways for life after high school.
- **Campus resources** – Access to academic advising, financial advising, online or in-person tutoring, the largest research library in the state, and more!

# AM I ELIGIBLE?

You are eligible to participate in the U of I Dual Credit Program if you:

- Are enrolled in a public or private high school or homeschool
- Have at least a 2.5 GPA
- Have approval of a parent or guardian





# DO I NEED TO TAKE A PLACEMENT TEST?

## YES, POTENTIALLY...

You must meet any prerequisites for the course(s) you wish to enroll in. Some classes require ACT, SAT, AP, or placement exam scores. The most common classes that require exam scores are:

- Math – You may take the ALEKS Placement Exam to determine which course(s) you are eligible to enroll in. ACT, SAT, or AP Math scores can also be used for placement into Math courses. - English - The Department of English looks at ACT, SAT, CEEB, and ISAT scores to place students in their appropriate course. - World Languages - Modern Language courses in the Global Languages Department use Avant PLACE Placement exams ([www.uidaho.edu/testing-center/placement-testing](http://www.uidaho.edu/testing-center/placement-testing)). Exams are available in Chinese, French, German, Japanese, and Spanish.

# WHAT DEADLINES SHOULD I BE AWARE OF?

It's important to know that the due dates and deadlines for courses taken online or on a U of I campus are different from those taken on your high school campus.

Failure to track the differing dates could result in late submissions that may affect your registration status or result in late fees.

# CAN I TAKE DUAL CREDIT COURSES IF I'M NOT 16 YEARS OLD?

## YES!

The registration process for students under 16 is similar to the registration process for students over the age of 16 but uses a paper registration form to fulfill the State Board of Education petition requirement. There aren't any restrictions on course eligibility due to age, but

students under 16 still need to meet the prerequisite requirements for courses they take.

# WHAT IS MY VANDAL NUMBER?

Your Vandal number is your personal U of I ID number (e.g., V00123456). Once you are admitted to U of I as a student, you will be assigned a Vandal number and will receive an email (sent to the email address you entered in DualEnroll when applying for admission) from Admissions with your number.

It's important to make a note of your Vandal number as all departments use this as one type of verification before providing personal information.

After you've been admitted, you can find your Vandal number under the **"Academics"** tab on your Dual Enroll page.

# WHAT IS MY VANDAL EMAIL?

Your Vandal student email is assigned once you are admitted to the U of I as a student; you will receive an email (sent to the email address you entered in DualEnroll when applying for admission) from Admissions with your new Vandal student email.

To activate your U of I account, which will grant you access to Vandal email, MyUI, and Canvas, you must complete the steps detailed here: [support.uidaho.edu/TDClient/40/Portal/KB/ArticleDet?ID=1702](https://support.uidaho.edu/TDClient/40/Portal/KB/ArticleDet?ID=1702). Once your account is activated, you will have access to all the U of I-associated platforms. MyUI will be your source for current course registration information. Vandal email is where all official communication from U of I will be sent. Canvas is where you will access course content, submit work, and communicate with your instructor.

## WHO DO I CONTACT IF I'M HAVING TROUBLE ACCESSING MY VANDAL EMAIL?

If you're not able to complete the initial set up or log in to your Vandal email account, contact the Student Technology Center at 208-885-HELP (4357) and select option 1; if you do not receive an answer, leaving a voicemail will create a ticket and the next available technician will contact you. # CAN I GET A VANDAL CARD?

## YES, IF YOU'RE REGISTERED IN AT LEAST 1 CREDIT AT U OF I!

The Vandal Card is your official U of I ID card, and is used to access library resources, tutoring sessions, Student Recreation Center, and for admittance to athletic events.

## WHERE DO I START?

Before you can register for courses, you must apply and be admitted to the University of Idaho as a dual credit student.

If you are a first-time dual credit student and do not have an existing DualEnroll account, you will need to create an account by clicking on the **Create My Account** link in the U of I DualEnroll portal. Enter an email or phone number that you have easy access to (not a parent's or guardian's email or phone number) as you will receive an email or text with a link to confirm your account; **your application will not be processed until you verify your account.**

If you have an existing DualEnroll account through another Idaho college or university, you will login to the U of I DualEnroll portal with your existing username and password.

All fields with a red asterisk (\*) on the identified pages are required.

Things to know during the application process:

- ✓ Make sure that you have your current GPA and, if you are enrolled in a public high school, your EDUID (your nine-digit state student ID number).
- ✓ Read, check the box, and type your full name to accept the *Student Acknowledgements* and *Financial Terms and Conditions* before proceeding.
- ✓ Parent or guardian contact information cannot be the same as the student contact information.

Once you've been admitted, you will receive an email from the U of I Admissions Department with your Vandal number and VandalMail address. You will use this information to activate your U of I account which will give you access to MyUI, Vandal email, and Canvas. You will use MyUI to verify your course registrations, drops, or withdrawals, check balances, make payments, and print unofficial transcripts. Your MyUI account can be used to access Canvas.

**MyUI is the official record.**

Once you have created and confirmed your account (if a first-time DualEnroll user) or logged in using your established username and password, you will complete



# HOW DO I REGISTER?

After you have confirmed your DualEnroll account and completed the application pages, you can begin the process of registering for classes.

In Dual Enroll, click on the **Courses** tab to review a list of available courses. The course finder shows which U of I courses are being offered at your high school or you can use the filtering options on the left to narrow the search or look for online courses or those being offered on a

U of I campus. Click on the course name to see the class description and available sections.

When you have found your desired course and section, you will click the **Request Course** button to start the registration workflow for that course; you may then choose to **Select another class**, **View current status**, or **Logout**.

Prereq: Sufficient score on SAT, ACT, or math placement test; or MATH 108 with grade of C or better. It is recommended that MATH 143 be taken within two years of passing MATH 108 or its equivalent. 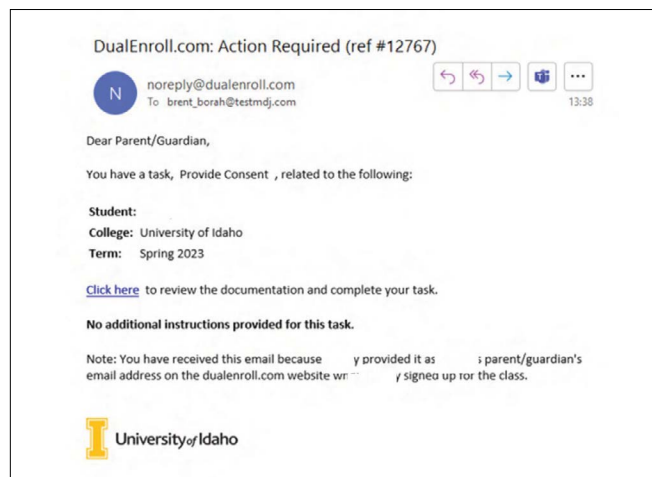

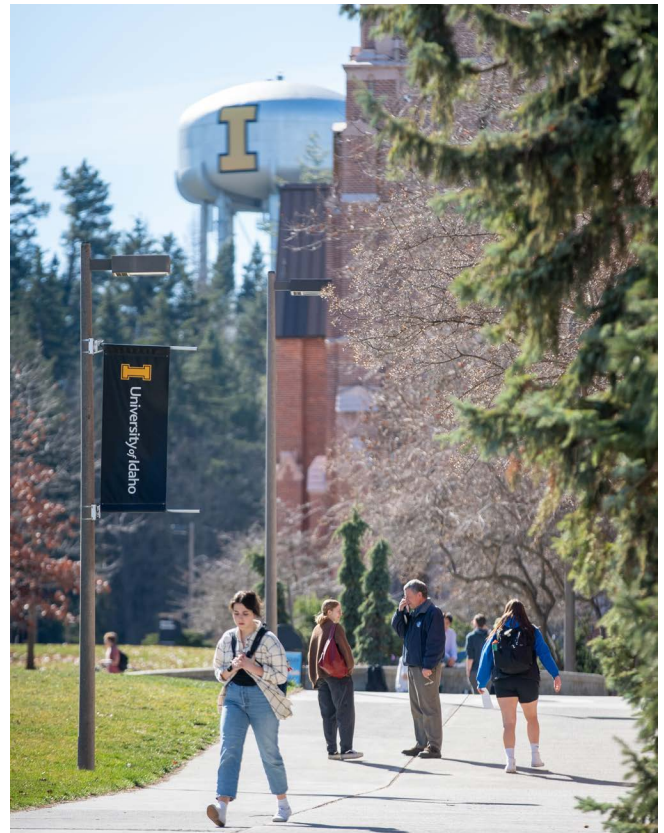
# DOES MY PARENT/GUARDIAN NEED TO DO ANYTHING?

## YES!

Once you have requested a course, if you are under the age of 18, the parent or guardian you entered on the **Parent Information** page will receive a text message or email to consent to the request. They must consent before the workflow will continue.



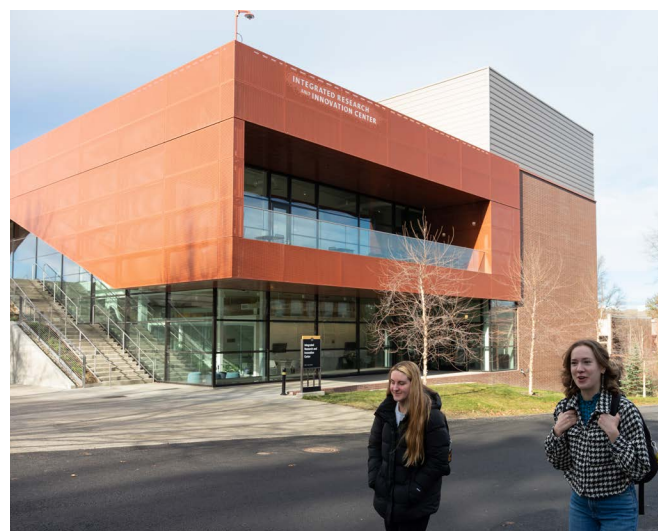
Your parent/guardian will continue to receive notices throughout the registration workflow.



# DOES MY HIGH SCHOOL COUNSELOR OR TEACHER NEED TO DO ANYTHING?

Once you have requested a course, your high school counselor or teacher must approve the request before the workflow will continue.





# WHAT COURSES SHOULD I REGISTER FOR?

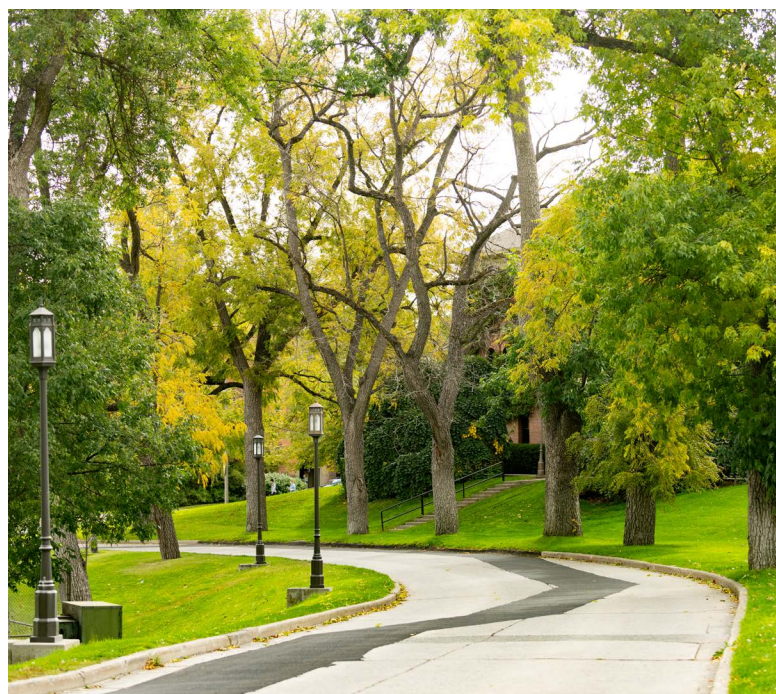
**Note:** Certain American Experience and International courses are cross listed with certain Humanistic and Artistic Ways of Knowing and Social and Behavioral Ways of Knowing courses; these can be used to satisfy both associated requirements.

- American Experience (1 course, 1-4 credits) Refer to list of approved American Diversity courses found in Degree Audit or the Catalog.
- International Course (1 course, 1-4 credits) Refer to list of approved International courses found in Degree Audit or the Catalog.

Note: The International course requirement may be waived if a student successfully completes an approved Summer, Fall, or Spring term abroad through the International Programs Office (IPO).

- Capstone Experience (1 Course) Refer to list of approved Capstone Experience courses found in Degree Audit or the Catalog.

**Students must complete a total of 18 credits within the J-3-e, J-3-f and J-3-g categories, and a minimum total of 36 credits in all categories to complete the General Education curriculum requirements.**





# WHY IS MY REGISTRATION NOT COMPLETING?

First, make sure that you've verified your account, parent or guardian has given approval (if under the age of 18), that your high school counselor teacher has given approval, and that no deadlines have passed.

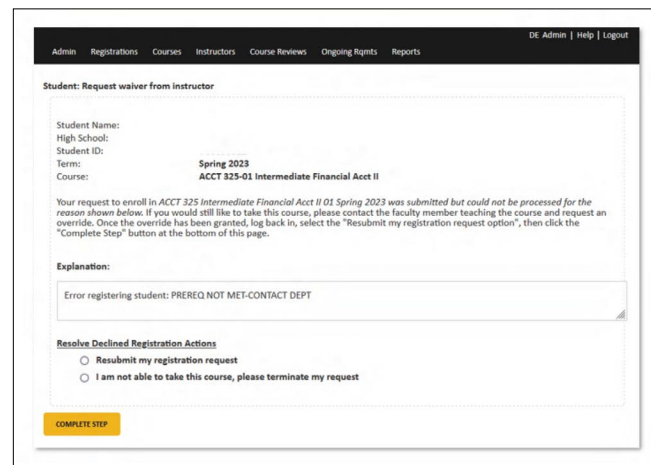
If these steps are completed and the registration window is open, then you may not meet the requirements for the course or there may be a hold on the course in MyUI. If U of I does not have a record of you completing a course's prerequisite or corequisite or if the course you've requested has a restriction that needs approval, your request will be denied.

You will receive an email or text with specific information about the course and any necessary action.

If you are directed to request a waiver and the teacher agrees that the registration is appropriate, they will enter an override in MyUI. After this has been entered, you must login to DualEnroll and resubmit your course request by selecting the **Resubmit my registration**

**request** option then **Complete step** to complete the registration process.

If the teacher denies your registration request, you will need to select the **I am not able to take this course, please terminate my request** then **Complete step** to cancel the course request.

# HOW DO I ADD, DROP, OR WITHDRAW FROM A COURSE AFTER THE DEADLINE HAS PASSED?

It is your responsibility to be aware of the differing dates and deadlines ([www.uidaho.edu/academics/dual-credit](http://www.uidaho.edu/academics/dual-credit)). We understand that life happens, however. If you need to enroll, drop or withdraw from a course(s) after the deadline has passed, you must fill out an academic petition prior to posted submission deadlines.

It is important to note that submission of an academic petition does not guarantee a successful add, drop, or withdrawal.

Below are the steps for submitting an academic petition:

- Complete the Academic Petition and Dual Credit Program Registration(if applicable) forms with


all necessary course information and required signatures: student, parent, counselor, and instructor (see example and signature map below).

- Pay \$10 petition fee through Student Accounts. Payment can be made with a credit card over the phone at 208-885-7447 or in-person at Bruce Pitman Center, Room 125.
- Email completed form(s) and payment receipt to [dualcredit@uidaho.edu](mailto:dualcredit@uidaho.edu).


Your petition will be processed and submitted to the appropriate Petition Review Committee member. The Dual Credit Office will contact you with the results.

## Things to know about submitting a petition:

- The course's unique class registration number (CRN), subject, number, and section must be included on both the Academic Petition and Dual Credit Program Registration forms.

# CAN I GET FINANCIAL SUPPORT TO PAY FOR DUAL CREDIT COURSES?

## YES!

The State of Idaho Advanced Opportunities (AO) Program provides every student, in grades 7-12, enrolled in an Idaho public school \$4,625 to use towards dual credit courses and approved exams. If eligible, AO covers \$75.00 per credit for courses.

Idaho students in grades 7-12 attending a Cognia-accredited Idaho nonpublic school are eligible to use up to \$2,500 in Advanced Opportunities funding. If eligible, AO will cover \$75.00 per credit for courses.

Things to remember about Advanced Opportunities:

- ✓ It is your responsibility to request funding in the Advanced Opportunities portal for AO funding prior to posted deadlines.
- ✓ **You will be responsible for any additional fees associated with the course** such as lab and online fees, books, supplies, and transportation.
- ✓ It is your responsibility to pay any charges not covered by AO on or before the term fee deadline. Visit the U of I Dual Credit page for specific deadlines.

**Note:** U of I dual credit summer courses are not eligible for the discounted tuition rate--you will be charged the current per credit tuition rate.

# HOW DO I PAY FOR DUAL CREDIT COURSES?

A bill will be sent to your Vandal email account.

Any balance remaining after Advanced Opportunities (AO) payments have been processed must be paid within 10 days of the start of your class to avoid late fees.

Once you are registered for your course(s), log into your MyUI account to view charges and make payments.

# I GRADUATED HIGH SCHOOL. NOW WHAT?

If you're planning to attend the U of I after high school graduation, you will need to submit an undergraduate admissions application through the Admissions Office and include your high school transcript and ACT or SAT test scores.

If you apply for admissions before graduating from high school, an unofficial transcript may be accepted for early admission, however, you must follow-up with a final, official high school transcript as well as official transcripts from any additional colleges or universities from which you've earned credit.

If you will be applying to another college or university, you will order a copy of your U of I transcript online through the National Student Clearinghouse or by fax or mail using the transcript request form. Visit the Registrar's Office Transcript page (<https://www.uidaho.edu/registrar/transcripts>) for more information.

You are responsible for verifying dual credit transferability with the institution you will be applying to.

**Note:** To ensure that you request transcripts for all dual credit courses you've participated in, review your Advanced Opportunities (AO) or Student Opportunities Assistance Program (SOAP) account to verify any colleges or universities attended as a dual credit student.

Transcripts will not be released if you have an outstanding balance owing to U of I. Accounts with balances greater than \$500 will not be allowed to register or drop courses.
