The following amounts were presented to the Interfraternity Council from chapter financial chairs. The semester of being a New Member is the most expensive due to one-time payments and New Member dues. The University of Idaho requires all first-year students to live on campus, therefore the amounts presented are the amounts for a student living in the chapter facility for the 2025-2026 school year.

All Greek Life students must pay a \$50 Greek Life Programming Fee each semester. This fee is billed through Student Accounts for the University and is applied during fall and spring semester. Please keep in mind that the Greek Life Programming Fee is not included in chapters' cost breakdown.

We hope this document is a resource to help Potential New Members and their parents/guardians be more aware of the financial commitments prior to joining our Greek Community.

Please note that fraternity finances are separate from the University.
